## Commanders Message

Today I write my message from 36.0 North – 114.44 West latitude in search of where our summer has gone, only to find the 80-plus degree air temperatures and the clear blue waters of Lake Mead. Lake Mead is fast recovering from a four-year draught, its depth reduced by nearly 100 feet at this time. And we thought our area lakes and rivers varied in depth throughout a dry summer! At the Boulder Dam, later designated the Hoover Dam after the 31<sup>st</sup> President of the United States, the Colorado River was harnessed as it flowed through the Black Canyon between Arizona and Nevada. The result of that project created what we now know as the Lake Mead Recreational Area, an approximate 1.5 million acre park that includes nearly 25 miles of the Colorado River. The scenery is absolutely amazing, clear blue 75 degree water beneath gaunt rocky cliffs, innumerable sheltered coves and flooded canyons everywhere. I may have found where our summer has gone.

By now, our boats are in storage, PFD's stored, fuel stabilized, and shrink wrap and tarps secured for the winter. With all the winterization tasks complete, what better time to begin thinking of the months ahead.

# Exploring the Coast

It was a wet and gray Saturday when Squadron members recently got into a car for a day trip to Burlington, Vermont. Their goal was to explore the Coast Guard station on the shore of beautiful Lake Champlain and, afterwards, to explore the natural wonders of the ECHO museum and aquarium located just a hop, skip, and a jump down the shore.

The passengers on this "cruise" were none other than Stephen Traver, his First Mate Jane Traver, and, yours truly, Lt/C David Wilkinson, Squadron Secretary. After they met up at the Log Jam restaurant in Queensbury, and consolidated their vehicles, they were off.

Despite the gray, wet weather, the drive was quite pleasant. The fall foliage was in full bloom and there were plenty of interesting things to see along the way. Along the way to Burlington, we passed through Vergennes, which turns out to be a quaint, charming area with a real small town feel. Further on, we passed by several farms, fields, ponds, and streams. Later on, we noticed that several of the streams seemed to have grown while we were puttering around Burlington.

The Coast Guard station in Burlington was quite interesting. Once we got inside the secure building, our tour included the communications center, mess hall, maintenance areas, where equipment and navigational aids are maintained, and their boats. Steve was especially impressed with the pair of 200 horsepower outboards that stood at the ready. At the time of our visit, they only had two boats in the water since it was late fall: A rigid inflatable and a rescue boat. Our guide also pointed out their ice rescue gear, which they were preparing for the winter season. The rigid boat, capable of reaching speeds of nearly 60 knots, was surprisingly roomy. The larger boat, which offers the resources for a weeklong cruise, was well

equipped, although a bit cozier. Our "Coastie," who was providing the tour, noted that the present Commander prefers that personnel are qualified on all vessels. This is a change in that he previously had only been qualified on the smaller boat. If the weather had been more favorable, we could probably have arranged a water tour but were forced to postpone it to our next visit.

Typical calls for the Coast Guard include lost mariners, vessels in distress, and even lost people. The Guard quite often works with other emergency service agencies for combined land and water searches and rescues. Their call volume is high, although they do experience some occasional quiet time.

# Waterford Tugboat Roundup

For sixty-four years (1922-1986) the *Urger* was a working tugboat on the New York State Canal System used in dredging operations and general canal maintenance. Built in 1901, steam-driven until 1948, the tug *Urger* ranks among the oldest vessels of her era still afloat and operational. Today, she is an educational vehicle, operated by the New York State Canal Corporation and perpetuating the living history of New York State's Inland Waterways.

In its heyday, the *W. O. Decker*, and its like were familiar sights on the Erie Canal, which was a major commercial trade that drove the economic engine of the communities, such as Waterford, that dotted its banks. Originally steam powered, she was sold to the Decker family in the 50's, when she acquired her current name. Currently, she is owned and operated by the South Street Seaport Museum in New York, NY.

The Waterford Tugboat Roundup began in 1999 as a way to preserve and promote the maritime industrial heritage of the New York State Canal System and other adjoining inland waterways. The tugboat history of the region, and particularly Waterford, is especially rich. For most of the 20<sup>th</sup> century, tugboats lined the shores here, whether waiting to lock up 169 feet through the magnificent flight of five locks or competing for some day work with a local company.

For one weekend each year, Waterford's historic waterfront is transformed back into a rendering of its commercial heyday during which names like Godfrey, Coyne, Bushey, Matton, Kehoe, and Cowles figured so prominently. Tugs new and old moor stem to stern for adulation and education, enchanting the young and reminding the young at heart of days gone by.

The event is sponsored annually by the Town of Waterford and the Waterford Maritime Historical Society, in addition to many generous corporate sponsors. Usually held the weekend after Labor Day, the festival has grown steadily and attracts approximately 25,000 people to this sleepy canal town in the heart of upstate New York's Capital Region. In addition to tours of the vessels, and other displays, there is an ample supply of music, food, children's activities, vendors, boat rides, fireworks, and family fun.

The ECHO museum was an interesting and delightful place to visit. A wonderful combination of educational and hands on activities was awaiting us once we went inside. We learned a lot about Lake Champlain and about the wildlife that can be found in and around the lake. While Jane browsed in the gift shop, Steve and I checked out a snake demonstration. Our afternoon concluded with a presentation in the style of the TV

show "CSI," offered by a detective from the Burlington Police Department. There we learned strategies to help prevent ourselves from becoming crime victims and we learned about our powers of observation and how different witnesses to an event may see it in different ways.

We stopped in town for some lunch then it was back on the road for our trip home to Queensbury. Steve had hoped to pick up some supplies since he wanted to finish winterizing his boat the next day. Unfortunately, the store had just closed by the time we got there. On the bright side, though, as we got closer to home, the rain slowed to a drizzle and finally stopped by the time we got back to the Log Jam.

This was a delightful trip which we all felt would definitely be worth doing, perhaps earlier in the year (late Spring, perhaps), when the weather is warmer but before the boating season gets into full bloom, so that the Coast Guard might have some time available to really show us what their boats can do.



## BOATING SAFETY

### TOUGHER PENALTIES FOR BWI

Man has been mixing alcohol and boating ever since he learned how to build boats and prepare intoxicating beverages. When they are misused, the combination can result in damage to and loss of boats as well as injury and loss of life.

Here are two reported instances; one from many years ago and one from this year:

About 100 years ago, the iron-clad sailing vessel *Glennesslin* was sailing off the coast of Oregon. She suddenly turned toward starboard and headed straight for shore. She struck a rock ledge and tore a hole in her bottom plates. The subsequent inquiry found that most of the sailors

were drunk at the time of the wreck. Luckily no lives were lost. (SOUNDINGS, February 2005)

This past summer, a deadly boating accident occurred on Fourth Lake in Herkimer County. A young man and five friends were in a 19-foot speed boat when it went airborne, struck an island, hit some trees and a lean-to before stopping nearly 150 feet inland. One young lady was killed and four other passengers were injured. The driver was unhurt. The accident occurred after they left a restaurant and bar. The driver has been charged with manslaughter and boating while intoxicated. (The Daily Gazette, July 26, 2006)

New York State has had a Boating While Intoxicated (BWI) law in place for a number of years. Three years ago the blood alcohol content threshold was lowered from 0.10 to 0.08 percent. This year New York State has increased the penalties for BWI.

In August 2006, New York State passed a law that increases the penalties for those convicted of BWI to make them match the penalties for driving while intoxicated. The first offense can now bring up to a year in jail and a fine of \$1000 for the misdemeanor. A second offense within 10 years can bring up to 4 years in prison and a fine between \$1000 and \$5000 and it is a Class E felony. A third offense can bring up to 7 years in prison and a maximum fine of \$10,000.

Boating While Intoxicated was always a bad idea and now with increased penalties it is even worse.

## Water-based Recreation Study Plan

*Lake George Park Commission  
Holmes and Associates - Researchers*

The purpose of the project is to provide a factual basis for the Park Commission to fulfill its legislative mission in regard to managing lake recreation and providing reasonable public access and safety. This project determined the first qualitative measures of Lake George water-based recreation providing a wealth of information on use and user perceptions. The recommendations contained in the report are the opinion of the researcher, Holmes and Associates.

The Lake George Park Commission is expected to consider the recommendations and any management actions at a later date. The revised draft report of the ***Water-based Recreation Study Plan*** is now available for review on-line at: <http://adirondackresearch.com/projects/la-ke-george>. Public comments in the form of a letter or e-mail will be accepted at the Lake George Park Commission ([www.lgpc.state.ny.us](http://www.lgpc.state.ny.us)) office until December 15<sup>th</sup>. At the next Park Commission meeting scheduled for November 28<sup>th</sup>, to be held at the Holiday Inn on Rt. 9, Lake George, a presentation and final opportunity for public comment on the draft will commence at the end of the Commission regular meeting, which is expected to be approximately 10:30 – 11:00 am on the 28<sup>th</sup>.

This would be on an experimental basis, with a three-year trial period. Joan noted that the Coast Guard Auxiliary pursued a similar course of action and, as a result, created a new membership category. The article indicates that the Mohawk-Hudson squadron is opposed to this proposed change. P/C Kelly asked if we are still perceived as a "private" organization. More information may be found by consulting the historical information in our Roster. Armand questioned why anyone would *want* to join without taking a boating course. For social reasons? To save money on insurance?
2. Lt/C McCarthy noted another article in *Scuttlebut* advertising the Tri-Squadron Holiday Party, which takes place on December 9<sup>th</sup> at the Holiday Inn in Schenectady.
